## **ORDINANCE NO. 762**

AN ORDINANCE AMENDING CHAPTER 14, SECTIONS 14-101, 14-102, and 14-103 OF THE CITY CODE OF THE CITY OF LINCOLN CENTER, KANSAS, BY ADOPTING AND INCORPORATING BY REFERENCE THE *STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES*, 52nd EDITION (2025); AND REPEALING EXISTING SECTIONS 14-101, 14-102, and 14-103.

BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF LINCOLN CENTER, KANSAS:

**SECTION ONE.** Section 14-101 of the City Code of the City of Lincoln Center, Kansas is hereby amended to read as follows:

**14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE.** The *Standard Traffic Ordinance for Kansas Cities*, 52nd Edition (2025), published by the League of Kansas Municipalities, Topeka, Kansas (the "Standard Traffic Ordinance"), is adopted and incorporated by reference except such portions as are hereinafter amended. At least one copy of the Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 762" with all sections thereof intended to be amended clearly marked to show any such amendments and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable business hours.

## 14-102. TRAFFIC INFRACTIONS AND TRAFFIC OFFENSES.

- (a) An ordinance traffic infraction is a violation of any section of this article that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 8-2118.
- (b) All traffic violations that are included within this article, and are not ordinance traffic infractions, as defined in subsection (a) of this section, shall be considered traffic offenses.
- **14-103. PENALTY FOR SCHEDULED FINES.** The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not be less than \$20 nor more than \$500. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense in which a fine has not been established in a schedule of fines shall pay a fine fixed by the court not to exceed \$500.

**SECTION TWO.** Existing Sections 14-101, 14-102, and 14-103 are hereby repealed.

**SECTION THREE.** This ordinance shall be in full force and effect from and after its adoption and publication once in the official city newspaper.
